Rt. Hon. Domitilla MUKANTAGANZWA The Chief Justice of Rwanda

Rt. Hon. MUKANTAGANZWA Domitilla has been serving as the President of the Supreme Court of the Republic of Rwanda and President of the High Council of the Judiciary since December 3, 2024 to date.

She is a Law Graduate from the former National University of Rwanda (currently the University of Rwanda). She further holds a Master's Degree in Peace Studies and International Relations from Hekima University College, Kenya and a Post Graduate Diploma in Legal Practice from the Institute of Legal Practice and Development (ILPD)-Rwanda.

She started her public career in the Ministry of Local Government in 1987 as the Assistante Bourgmestre of Commune Nyarugenge in the Capital City of Kigali and later as the Legal Officer in charge of legislation and civil litigation in the Ministry for Agriculture and animal resources.

From July 1994, she held various positions respectively in the Ministry of Social Affairs and Labor (MINITRASO) as Director General; United Nations Children's Fund (UNICEF) as National Project Officer in Charge of Unaccompanied Children Department; Constitutional and Legal Reform Commission as Commissioner; Executive Secretary of National Service of Gacaca Courts and Chairperson of Rwanda Law Reform Commission.

Hon. Dr Emmanuel UGIRASHEBUJA Minister of Justice / Attorney General of Rwanda

Emmanuel Ugirashebuja is the Minister of Justice and Attorney General of the Republic of Rwanda. He is a former President of the East African Court of Justice. He is a Dean Emeritus of the National University of Rwanda, Faculty of Law and has given lectures on diverse subjects of law to various well-renowned Universities worldwide. He was educated and has practiced in the major legal systems, namely, common law and civil law systems. In addition, he has been bestowed confidence by his peers by being elected to different judicial and legal bodies, notably; the Global Judicial Institute on the Environment, supported by the UNEP and IUCN; He is also a member of the Governing Board of the International Association of Law Schools.

He was Awarded a Lifetime Appointment as a Distinguished Fellow & Eminent Jurist at Jindal Global Law School, OP, Jindal Global University India as "exemplar jurist and contribution of law and Justice which have transcended geographical boundaries and jurisdictional limitation"; the 2019 Bright International- Juristin Residence University of Hawai'i School of Law. Dr. Ugirashebuja holds a PhD and LLM awarded by the University of Edinburgh and a Bachelor's Degree awarded by the National University of Rwanda (Currently, University of Rwanda).



Andrew Dabalen Chief Economist, Africa, World Bank

Andrew Dabalen is the World Bank's Africa Region Chief Economist since July 1, 2022. The Chief Economist is responsible for providing guidance on strategic priorities and the technical quality of economic analysis in the region, as well as for developing major regional economic studies, among other roles.

He has held various positions including Senior Economist in the World Bank's Europe and Central Asia Region, Lead Economist and Practice Manager for Poverty and Equity in Africa and most recently, Practice Manager for Poverty and Equity in the South Asia Region. His research and scholarly publications focused on poverty and social impact analysis, inequality of opportunity, program evaluation, risk and vulnerability, labor markets, and conflict and welfare outcomes. He has co-authored regional reports on equality of opportunity for children in Africa, vulnerability and resilience in the Sahel, and poverty in a rising Africa.
